1. STATUS AND NATURE OF ACTIVITIES

Organisation Je suis Heshima is a registered Charity organization since January 1st 2020. The mission is to empower Youth through education for those who have been denied their right to quality and affortable education, kepping in mind the importance of community engagement.

2. BASIS OF ACCOUNTING APPLIED IN THE PREPARATION OF THE COMPILED FINANCIAL INFORMATION

The basis of accounting applied in the preparation of the compiled financial information is based on the historical cost, taking into account treasury operations and the following:

- inventories valued using the retail price method
- revenue recognized in the year to which they relate
